## TERMS AND CONDITIONS

1. Signing this Mandate the Client gives to Prime Advisory Network Ltd, hereinafter "Prime", the task to provide the services mentioned in the above section, through the payment of the respective fee.
2. The Mandate will terminate after 12 months from the subscription and it will be automatically renewed for the same period in absence of written notice sent from the Client to Prime by post (tracked system) or mail (certified or secure mail) at least 60 days before the termination.
3. The Mandate includes all the obligations and practices specified in the service section whose deadline appears to fall within the term of the contract, including any renewed period.
4. The fees can be subject to inflation rate detected in the Country and they can be changed by Prime at the end of the twelfth month of each year.
5. The Client undertakes to pay fees for assistance services provided in advance, within the 10th of each month, by credit card or bank transfer in favor of Prime at the bank details provided. The Client agrees that any payments made directly to the member of the network can not be considered valid for the purposes of fulfilment of the amount due and must be carried out again in favor of Prime. The Client shall entitle to ask the refund to the member who received the sums.

The Client acknowledges and accepts that for any liability related to the service provided shall only be liable the Partner of the network identified in the Services Section of this contract, with the express exclusion of any responsibility on behalf of Prime.

Prime may change at any time the partner chosen to perform the service, as the terms and conditions of this Contract, the expenses, the change rates, the commission requested for the services, by communicating to the Client the variation in any suitable form that assure a receipt of notification. The Client may withdraw from the Mandate within 60 days from the communication. In absence of withdraw, the variation will be considered accepted.
8. Any complaints and communications to Prime will be sent by email to the address identified in the header.
9. The official language for this Mandate is English. Translations are not relevant for the official interpretation.
10. The Mandate is construed and governed by law of England and Wales. Any dispute arising relating to the execution or interpretation of this contract shall be submitted to the exclusive jurisdiction of London.
